#### 1. CALL TO ORDER

The Chair called the meeting to order at 10:30 am.

The draft 2021 Strategic Plan and Profile of the Invasive Plants was shared via email to
members. Included in that email was a partner and stakeholder survey requesting
feedback from members regarding 2020 invasive plant activities, strategies, newly
reported invaders and successes as well as recommendations for 2021 activities.

The purpose of today's meeting is to check in with members to provide updates on their 2020 year and invasive plant management plans for 2021.

Ministry of Forests, Lands and Natural Resources	<ol> <li>treating highest priority areas within the North, South and West Peace areas</li> <li>Continue with Regional EDRR for Marsh Plume Thistle</li> <li>Province wide there will be no joint contracts for public lands this year.</li> <li>The Ministry of Transportation and Infrastructure has funds and will be doing their contracts as usual.</li> </ol>

Enforcement issue, local oil and gas company not spraying – poor approach.</li> </ol>
Northern Rockies Invasive Plant Committee	<ol> <li>Contract, industrial part of Fort Nelson, intense assessment and control took place in the second half of summer</li> <li>NRRD Invasive Plant Committee – leftover funding from the pooled funding model. Trying to determine best use of funds. Have invasive plant site list for possible treatment. Also need to focus on education.</li> </ol>
MGP Contracting	<ol> <li>Area Controller for the Regional District. Slow and steady, lots of spraying</li> <li>Continue with monitoring and treatment</li> <li>Continued support from staff. Operational questions answered within the hour.</li> </ol>

Logging training, post harvest assessments.</li> <li>Regional District has great resources.</li> </ol>
Blueberry First Nations	<ol> <li>Invasives not a number 1 priority currently. Continue with outreach and engagement</li> <li>Share materials that could be posted to our website.</li> </ol>
Regional District	Reporting: Report a Weed App Call office – Regional District has a Compliance and Enforcement Officer Roadside or industrial – report directly to the Ministry of Transportation and Infrastructure or the BC Oil and Gas Commission
Wash stations	Concern was expressed that vehicles from industrial sites are not being adequately washed to stop the transference of weed seeds, needs to be addressed. It was noted that there is a full rinse station located at Old Fort - all vehicles coming in or going out – have seen a dramatic decrease in the spread of seeds. BC Hydro continues to work with contractors on "off site" locations – points of inspection prior to exiting onto highway or shared roads. Well received at BC Hydro, increase education to prevent the spread of weeds by wheel.
Funding for invasive plant program	Concern was expressed that the Province is not recognizing the economic contribution agriculture makes to the province. It was recognized that cancellation of treatment work on public lands by the Ministry of Forests, Lands, Natural Resource Operation and Resource Development (FLNRORD) could result in the spread of invasive plants on FLNRORD lands going unchecked and affecting neighbouring agricultural lands. There was consensus that a letter be forwarded to the Ministry of Forests, Lands, Natural Resource Operation and Resource Development (FLNRORD); Ministry of Environment and Climate Change Strategy (BC Parks and Conservation divisions) emphasizing the economic benefits agriculture provides versus the detrimental costs of cancelling treatments of invasive plants on FLNRORD lands.
Fall Meeting	Members were asked to forward any topics or issues to the Regional District for the fall meeting. Or call if anyone has any pressing issues.
ADJOURNMENT	The Chair adjourned the Meeting at 11:30 am.

#### Rancher's Contract Update Submitted by Brian Stratuliak

To the dismay of the Sunset Prairie Livestock Association, we were made aware during our April meeting that the funding of the Rancher's Contract with the Ministry of FLNRORD was canceled. The SPLA sent letters to the Ministries of FLNRORD, Environment, & Agriculture, the ALC, our local MLAs, and the corresponding Liberal critics to voice our displeasure with their decision. We also contacted, and got support from, the Peace River Regional Cattlemen's Association, BCCA, South Peace Stockmen's Association and other individuals in trying to reverse the government's decision. The SPLA would like to thank the PRRD Invasive Plant Monitoring Committee for writing a letter to help reinstate our funding.

On June 10, I received an email from Darlene Dresser of FLNRORD informing us that they were proceeding with our contract, with a slight increase in our funding. We were then able to continue our work this summer with controlling invasive weeds in our pasture. This program has been a huge success, and we are treating less acres of invasive weeds every year.

The government funded portion of the Rancher's Contract is to spray high priority invasive weeds on crown grazing land. The SPLA also sprays Canada Thistle on the crown grazing land, but with the labor at their own expense. This year the government paid for surveying, spraying &/or hand pulling of weeds on 8 sites, all Scentless Chamomile. They sprayed .04 ha (.09 acre) with Clearview, and hand pulled 2 sites (40 plants). The SPLA sprayed 2 sites for Canada Thistle with an area of 46.1178 ha (113.9596 acres) and the chemicals used were Clearview, Milestone and Grazon XC.

## Strategic Plan and Profile of Invasive Plants Monitoring Committee of the Peace River Regional District Terms of Reference

### 1. Goal

1.1 To complement the Mission, Vision, and Goals of the Regional District by: "protecting our economy, environment and social values from invasive plants and ensuring that existing infestations are managed with integrated pest management".

#### 2. Purpose/Scope

- 2.1 To act as a forum to network and provide feedback to the Invasive Plant Committee of the Peace River Regional District (IPCPRRD) regarding:
  - a. the Strategic Plan and Profile of Invasive Plants;
  - b. the effects of noxious/invasive plants in the region;
  - c. advice regarding best practices for industries operating within the Region;
  - d. noxious/invasive plant occurrences;
  - e. information on matters referred by the IPCPRRD; and,
  - f. any other matters related to noxious/invasive plants.

#### 3. Accountability

- 3.1 Roberts Rules of Order apply.
- 3.2 Recommendations will be made to the IPCPRRD as required.

### 4. Committee Organization

- 4.1 A Chair and Vice Chair will be appointed by the IPCPRRD.
- 4.2 Secretarial services will be provided by the Peace River Regional District.
- 4.3 Members may be chosen to form an Advisory Committee and provide technical advice.

### 5. Membership

5.1 Membership is open to all who are interested in noxious/invasive plant management.5.2 Membership will be continuous.
