14. Staff Discounts

- All District of Chetwynd employees including casual, student, temporary, term and permanent staff receive 50% discount when purchasing a pool or gym multi-visit or pass.
- Seasonal Employees will be eligible for the discounts above provided that they are currently
 working for the District of Chetwynd and that they are limited to purchasing passes during their
 current term of employment. (ex: summer student can only purchase a pass up to the end of
 summer).
- Permanent Employees (part-time and fulltime) will receive an additional \$150 per calendar year toward any health & wellness fitness program offered by the Chetwynd & District Rec Centre.
 Employees to pay full amount upon registration, submit receipt to the District of Chetwynd for reimbursement of 50% of the total purchase price.
- Discounts apply to employees only; family members do not receive any discounts.
- The Aquatic Staff have free use of the pool and gym to keep up their fitness standards. The free use for the gym does not include after hours access, the policy for after hours access will apply.

15. Disability Discount Admissions

- Access to the facility for those who are permanently disabled will be coordinated through the Director of Recreation or the Manager of Leisure & Facility Services.
- Membership cards will be issued by the Director of Recreation or the Manager of Leisure & Facility Services once proper paperwork can be verified.
- Only offered to those permanently disabled, not for those on ICBC, WorkSafe BC Claims or anyone who is required to "be active" for health reasons.
- NOT ACCEPTED: a Doctor's note stating temporary or permanent disability, Physiotherapist request for exercise therapy, long or short term disability through employer benefits ex: BCLife, WCB Claims, ICBC Claims.
- Obvious permanent disability may be admitted without charge. Examples would include a group coming from Dawson Creek with the Society of Community Living, whose individuals have permanent disability support and income from the province.
- This policy covers free use during public swim or gym times, in normal operating hours.
- There is no cost for a "helper or aid" to attend the activity with the disabled participant.
- The helper or aid is there to assist the client, not to participate for personal benefit for example: fitness workout.
- Fitness class admission is at 50% off regular drop-in rate.
- Swim Lessons, Programs, Personal Trainer etc. are at regular rates.
- Application Process: Complete our application form, attach proof of disability benefits from the province (T-4 from Revenue Canada) and return in envelope for review by the Director of Recreation or the Manager of Leisure & Facility Services.
- The application will be reviewed and the customer will be contacted with the outcome of the application.

16. Managing the Rental Rate Discount Policy

- If a group or organization feels there would be undue hardship as a result of this policy, they can appeal to the Civic Properties Commission either as a delegation or in written form and it will be placed on the next Commission meeting agenda. Written submissions should be directed to the Commission and c/o the Director of Parks & Recreation.
- If an organization is granted a discount from the Commission, then the rate reduction applies to the room rental rate only. Insurance, liquor licenses and additional staff time for clean-up would not be considered in the discount.

Policy Manual

1.64 District of Chetwynd Employee Fitness Discount

Civic Properties Commission has approved (Feb./03) a 50% discount off passes and punch cards to all regular part-time and full-time employees of the District of Chetwynd. The program is in place at the Rec Centre and Leisure Pool and includes the Weightroom, Leisure Pool, drop-in Water-Fit classes, and fitness classes at the Rec Centre instructed by a staff person. (fitness classes instructed by a contractor who receives a % of registration fees does not qualify for inclusion in this program) All other programs are at full price.

The program is limited to employees only. Employees family members may not use the passes or punch cards.

Employees must sign in each time they use their card/pass.

Temporary and casual employees will pay regular prices.


