Subject: Seniors Housing in the Regional Hospital District

PURPOSE/ISSUE:

To discuss seniors care facilities in the Regional Hospital District.

RECOMMENDATION/ACTION: [Corporate Unweighted]

That the Regional Hospital District Board request that Northern Health provide the Regional Hospital District Board with the population data and projections used to determine the bed count for the recently announced expansion project to add additional seniors housing beds to Peace Villa in Fort St. John and any other information relative to seniors care housing demands that is being relied upon to inform future seniors care housing capital project investment decisions for the Northern Health region, so that the Regional Hospital District Board can understand the long term plan and targets currently in place to provide adequate health/seniors care in the region.

BACKGROUND/RATIONALE:

Now that the Peace Villa has been announced, the Peace River Regional Hospital District is unaware of any additional senior care facilities that may be needed in the region. Attached is a press release regarding the Peace Villa expansion project and a press release from September 2024 regarding a long term care (LTC) residence expansion project in Penticton BC. The facility announcement for the project in Penticton (Interior Health) includes additional information about overall expansion targets to meet projected needs, including:

- Interior Health has benefited from an increase in publicly funded LTC beds from 495 to 605 since 2018.
- Ministry of Health plans include adding a total of 495 new LTC beds to Interior Health (no deadline associated with this statement).
- Increasing demands witnessed over the past five years are proposed to be met with a government investment of approximately \$3.5 billion to expand and improve the quality of care of seniors in British Columbia (entire province).

Members of the Regional Hospital District Board have expressed concern that the 84 long term care beds being built to expand Peace Villa is not enough to meet current or future needs and receiving the population data and projections would help the Regional Hospital District Board understand the situation.

STRATEGIC PLAN RELEVANCE:

Senior's Housing (Advocacy)

Advocacy for investment in Seniors Housing to ensure seniors are able to age in their communities is identified in the PRRD Strategic Plan. If the data relied upon by the Ministry of Health/Northern Health supports additional investment, the Regional Board will be able to advocate for such investment.

New long-term care beds coming to Fort St. John

Residents in the Northeast will soon have access to additional long-term care beds as the business plan has been approved for an expansion to Peace Villa in Fort St. John.

"As Fort St. John continues to grow, so does the need for strong, modern long-term care infrastructure," said Bowinn Ma, Minister of Infrastructure. "This newly approved long-term care home is a generational investment—expanding access to quality care for seniors, strengthening health services in the region, and creating meaningful jobs for the community."

This addition is being funded jointly between the Ministry of Infrastructure, through Northern Health, and the Peace River Regional Hospital District and will bring 84 new single bedroom long-term care beds to the region. In addition, the project will include a 30-space adult day program as well as social and recreational spaces.

"On behalf of the PRRHD, I am thrilled that this new long-term care facility project is advancing," said Leonard Hiebert, PRRHD Chair. "The expansion means that our seniors can receive the care they need while staying within their communities. Together with all the local community advocacy that has been done, I also want to recognize our partnerships with the Ministry of Infrastructure and Northern Health for their support in reaching this essential regional milestone."

This project is part of an overall investment of over 600 additional long-term care beds in the North with new long-term care facilities being developed in Prince George, Smithers, Quesnel, and Fort St. John.

The project is taking place in Treaty 8 territory and is expected to begin construction in Spring 2027 with the facility being open for residents in late 2030.

"Our government is expanding new long-term care homes around B.C., building on our commitment to ensure people receive the highest-quality care in modern, safe facilities," said Adrian Dix, Minister of Health. "Kaigo Senior Living has a track record on delivering quality long-term care services and the capability to build a 200-bed care home in Penticton. This partnership with them will significantly increase people's access to more LTC beds to support their needs as they age and increase the overall number of publicly funded LTC beds in the Interior Health from 495 to 605 since 2018."

Interior Health has awarded the project to Kaigo Senior Living. Experienced as a developer and operator of long-term care services, Kaigo Senior Living will design, build and operate the facility.

"This new long-term care home will be a place for people to live in a comfortable, home-like environment with all the amenities they need, close to their families and loved ones," said Harwinder Sandhu, Parliamentary Secretary for Senior Services and Long-Term Care. "This is big news for people in Penticton and throughout the area and I'm thrilled our government is moving forward with this project."

Detailed design is underway, with construction expected to begin in spring 2025 and complete in 2028.

"Caring for our seniors is a responsibility we hold close to our hearts," said Susan Brown, president and CEO, Interior Health. "Increasing the number of long-term care beds in Penticton is about more than just addressing a need, it's also about providing our elders with the respect and comfort they deserve. We are excited and grateful to partner with Kaigo Senior Living to bring 200 new long-term care beds to the community."

The 200 new long-term care beds in Penticton are part of the government's investment plan to add a total of 495 new long-term care beds within the Interior Health region to meet the needs of the growing seniors' population. The remaining beds are planned for facilities in Kamloops, Kelowna and Nelson, as well as the 90 beds opened in Vernon in February 2024.

Long-term care homes provide care to individuals with complex-care needs who can no longer live safely and independently at home. Long-term care homes provide 24-hour nursing care delivered by a team of well-trained, compassionate and caring staff, including allied health staff.

To meet the increasing demand witnessed over the past five years, the government has invested approximately \$3.5 billion to expand and improve the quality of care for seniors in British Columbia. This funding includes improvements in primary care, home health, long-term care and assisted living.

BACKGROUND/RATIONALE:

The Peace River Regional Hospital District (PRRHD) adopted Peace River Regional Hospital District 2025 Annual Budget Bylaw No. 215, 2025, on February 20, 2025. The annual budget is based on a draft budget submitted in the fall by Northern Health. As individual projects are approved at Northern Health, bylaw requests are sent to the Hospital District.

Section 32 of the Hospital District Act states that "A Board that proposes to borrow or spend money to meet capital expenditures, must prepare, in consultation with the minister, and enact, a capital bylaw permitting the borrowing or spending of that money." Therefore, adoption of a capital expenditure bylaw is necessary in order to release funds for Northern Health's budgeted capital expenditures.

1. That the Peace River Regional Hospital District Board provide further direction.

FINANCIAL CONSIDERATION(S):

The Hospital District 2025 Annual Budget includes \$5,192,920 for Annual Equipment and Major Projects. Peace River Regional Hospital District Capital Expenditure Bylaw No. 217, 2025, authorizes \$782,920 of that total to be paid to Northern Health.

Dear Minister Ma:

On behalf of the Northern Regional Hospital Districts, we would like to thank you and your team for meeting with us on May 8. We appreciated the opportunity to voice our concerns on the current state of affordability and equity under the current *Hospital District Act* and the need to work together towards legislative reform of the *Act*.

As noted in the meeting, when compared to other areas in BC, the six northern regional hospital districts pay some of the highest requisition rates per average household. As a result, fairness for taxpayers across the province is in question. Northern communities are also dealing with industrial closures and cutbacks impacting the tax base and challenges to hospital service level provision due to smaller populations and large geographic areas.

The negotiation of regional hospital district contribution levels for priority capital investment projects is inconsistent across the province. Capital funding requests also continue to increase significantly each year, in addition to priority investment projects. Regional hospital districts feel they cannot say no to the provincial funding requests on capital projects that continue to significantly increase in cost, for fear of jeopardizing their region's healthcare services.

The Regional Hospital District model is outdated and increasingly unsustainable. The original legislation dates to 1967, and it does not reflect the reality of delivering healthcare in 2025. Technology is advancing faster, reinvestment is needed, and both equipment and facilities are far more complex and costly than ever before. Healthcare costs have escalated significantly, and they will continue to do so. The Province is in a spending wave and regional hospital districts and their taxpayers are being asked to pay for more, more often.

We look forward to upcoming discussions and appreciate the opportunity to work with the Ministry of Infrastructure staff to examine our funding and affordability concerns, and work towards the legislative reform of the *Hospital District Act.* As you indicated during the meeting, please have Deputy Minister Bobbi Plecas coordinate a staff meeting at your earliest convenience through:
