 The facility operation continues under the approved and amended COVID safety plan, restrictions, and rules. Operational hours, staggered start and stop times, foot traffic flow, number of attendees, social distancing, attendants, and enhanced cleaning protocols remain in place to ensure patron and employee safety.

- The safety plan continues to be modified as new Orders are received. Staff have received training
  on the new Orders and all the changes have been posted and displayed for our patrons.
- There are have been very few incidents reported regarding the new restrictions and protocols; primarily relating to patrons not wearing masks or neglecting to maintain the required physical distancing requirements. Staff have received direction to ensure that these requirements are met at all times. Patrons have generally been receptive to reminders of the new rules and compliance is very good and continuing to improve. Most patrons continue to be supportive and understanding and there have been few conflict incidents reported.
- The Curling Club is operating at a reduced capacity under their new restrictions. Games are reduced
  to two participants and junior curlers are recreating as normal. The lounge is operating for adults
  under the approved Safety Plans and current restrictions.
- The sound system installation is complete and is a dramatic improvement. This project was later than anticipated due to COVID supply chain disruption but finished under budget.
- The High School as resumed some PE class use of the facility while following all current guidelines and restrictions. SD 59 is conforming to the Rec Centre Safety Plan and we are very pleased to be able to once again accommodate our local schools.
- Concern remains regarding further restrictions, although cases are showing a small downwards trend in BC. The current PHO remains in effect until February 5. Staff will continue to maintain close contact with, and close monitoring of, relevant Government departments and recreation professional organizations. Protocols and procedures for operating safely continue to be developed and amended in cooperation with all relevant regulatory bodies.





Attached are the preliminary year-end budget summaries from 2020. These numbers will change as part of
the normal year-end financial process as funds are transferred, grants are received, and outstanding invoices
are paid.

- As anticipated, the COVID-19 pandemic created a significant impact to the projected revenue. The Pool Revenues are at 48.26% while the Rec Centre ended at 75.58%. Expenses were at 66.22% for the Pool and 105.86% for the Rec Centre. Please note that the Rec Centre expenses will come down as part of the year-end accounting process. Line "823 Building Improvements" which reflects capital projects skews the overall expenses at 717% over budget, or just over \$538,000.00. This represents \$125,000.00 carried over from 2019 for the purchase of the Zamboni Ice resurfacer, with the remaining overrun caused by the 2020 Indoor Playground project. This project was paid for through grants and community donations and this budget line will be reduced accordingly as funds are received.
- The two prepared options for the provisional 2021 operating budget each offer a significant reduction from 2020. This is despite an increase in costs for operating, goods and services, contracts, inflation, and negotiated wages. Additionally, \$100,000.00 was reallocated to the operating budget from what had been capital budget costs in past years.
- The latest provisional budget reflects a decrease in tax revenue required to operate the Rec Centre of \$51,063 for the pool and \$54,662 for the arena, while still reflecting an overall increase in wages of \$27,275 for both facilities. For reference, a 2% increase on 2020 wages would amount to \$43,941, so we have reduced staffing below previous levels. During the December 1 Civic Properties Commission meeting, staff were directed to provide additional cost savings options for wages and this provisional budget provides the directed reductions.

**Option 1** is similar to what was presented on December 1 and includes a modest increase that reflects negotiated wage increases, succession planning, and actual hours worked by facilities staff. The adoption of option 1 results in a zero increase in tax payer dollars between the 2020 and 2021 overall operational budgets. This preliminary budget was approved by the Civic Properties Commission during the December 1, 2020 meeting with the understanding that changes might be needed depending on surplus levels and tax base calculations. At the time this report was written, the Rec Centre 2020 surplus levels stand at approximately \$515,000.00.

**Option 2** would result in approximately an additional \$100,000.00 reduction in the 2021 operational budget through cuts in wages and budgeted positions. Please note that further cuts may require a staffing freeze, some reduction in existing staffing hours, and/or the potential for a reduction in services offered to the facility patrons.
