- Approximate sewage waste production for a 500 man camp;
- The number of active Temporary Use Permits (TUP) issued in the Peace River Regional District;
- Approximate cubes per day processing facilities produce within the region; and,

Director Bumstead compared those numbers to the number of cubes of waste that come into the Trucked Waste Facilities. After raising concerns regarding illegal dumping and the unknown number of camps in the Region, Director Bumstead advised that he would speak with the Ministry of Health and Northern Health to find out who is monitoring the waste.
