Treasurer Report

Library Director – Report as submitted including stats, social media update, yearend reporting status, thank you gifts for our past library directors and to DB for taking such good care of our library pets. Library programming updates: virtual kitchen, seed library, Friday flashlight, children's art gala, earth day. Meetings attended by LD, update on grants and funding as well as staff notes with update on inventory, parent caregiver make & take, preschool zoom programs, library on location, cataloguing, poster design, displays, craft kits, and regularly sanitizing the premises.

(NELF) North East Library Federation Representative — with GM resigning from the board we will need to appoint two representatives from the CPL board to sit on the NELF board. One to hold the position and the other as their alternate. NELF has already replaced GM's roll as chair with a member from one of the other NELF libraries. NELF meets twice a year, one being in person. Three years ago, it was decided to have each library host the annual meetings at their home libraries opposed to hotels with Chetwynd being the first one. In 2019, our NELF manager who resides in Prince George rented a van and we travelled to Fort Nelson. The next one is scheduled to be in Tumbler Ridge when we can have in person meetings again. In the meantime, meetings are through zoom. There are seven northern libraries that are part of NELF, all except for Dawson Creek. Along with the networking opportunity for the northern libraries, we are able to purchase library items as a consortium, therefore saving money on bulk purchases. There is not a lot of work to do, you are the spokesperson for Chetwynd and it is a great way to learn about libraries.

District of Chetwynd – The District of Chetwynd purchased a duplex to house the new Doctors. Spray park equipment has gone out to tender and an application for a second non-cannabis store in Chetwynd is currently in process.

Peace River Regional District – Budget time is winding down and it is business as normal. DR would like to talk to the District of Chetwynd council about where we are at with the new library.

Library Project Committee – Tenders are out. SH did a bit of a recap on the timeline and planning of the library as well as past discussions in relation to the bistro.

SH and LD will locate a space in the library that can be used to display information about the new library as it progresses.

KP gave an update on the strategic plan. The committee has met and are working towards short and meaningful statements that are motivational and reflect the fulfilling services that we offer. The committee is open to suggestions, especially from the building committee on more specifics with the new library.

MOVED by SH, SECONDED by ZS-C That we restrict the Literacy Project fund and Resource Corner fund accounts for the new library – CARRIED

Bylaws, LD will email out a copy to all members so they can review and we can discuss at a later meeting.

GM thanked everyone and wishes the library board all the best. She had two things that she wanted to ask the board for; one, a CPL library card to give a family member that collects them and two, an invite to the grand opening of the new library.
