- A registered owner of real property in Chetwynd, Tumbler Ridge, Hudson's Hope, Taylor, or Area B of the Peace River Regional District for at least 30 days;
- Not entitled to register as a resident elector; and
- Not disqualified from voting by the *Local Government Act* or any other Act.

The Regional District may proceed with the adoption of 'Gotta Go Roadside Facilities Service Establishment Bylaw No. 2440, 2021' unless **796** electors sign and submit a **fully completed copy** of this elector response form to the local government by July 5, 2021.

A person must not sign more than one elector response form in relation to this alternative approval process.
