Subject: RFP Award 04-2021 'Cellular Phone Services'

### **RECOMMENDATION:** [Corporate Weighted]

That the Regional Board award RFP 04-2021, 'Cellular Phone Services', to TELUS Communications Inc., at a cost of \$117,720 (excluding taxes) over a 3 year period starting July 1, 2021; further, that the Chair and Chief Administrative Officer be authorized to sign the agreement.

## **BACKGROUND/RATIONALE:**

On March 25, 2021, the Peace River Regional District (PRRD) issued a Request for Proposal for qualified telecommunication companies to provide cellular services for staff smartphones, landfill and transfer station cellular connectivity, and water station connectivity. PRRD also relies on cellular for fleet vehicle tracking and maintenance monitoring.

The PRRD received three proposals; Bell Mobility Inc., TELUS Communications Inc., and Rogers Communications Canada Inc.

TELUS Communications Inc. was the highest scoring proponent. Rogers Communications Canada had the lowest bid, however, while their coverage map includes most of the PRRD infrastructure areas in the region, the other two proponents, Bell and TELUS have <u>complete</u> cellular coverage.

The TELUS proposal cost was lower than Bell, and TELUS is waiving the current outstanding device balance, providing a discount for new hardware, and offering loyalty credits to the PRRD. TELUS has committed to reducing fees on their feature set, such as reduced costs for static IP addresses and free voice-to-text/visual voicemail services.
