Subject: PRRD Grant Writer Services

RECOMMENDATION #1:

That the Electoral Area Directors Committee recommend that the Regional Board authorize a contract extension for Contract 42-2020 'Grant Writer Services' with Clear Course Consulting Limited for an additional one year term, starting March 1, 2022, and ending on February 28, 2023, for an amount not to exceed \$85,050 (excluding taxes); further, that the Chair and Chief Administrative Officer be authorized to sign the contract extension on behalf of the PRRD.

RECOMMENDATION #2:

That the Electoral Area Directors Committee recommend that the Regional Board submit a grant application to the Northern Development Initiative Trust Grant Writing Support program for a grant of up to \$8000 that, if successful, will be used to offset the cost of a PRRD Grant Writer.

BACKGROUND/RATIONALE:

Grant writer services are provided by Clear Course Consulting Limited through the PRRD Grant Writer Services Contract No. 42-2020. The contract's completion date is February 28, 2022 with the option to extend for an additional one year. Between March 1, 2021 and October 31, 2021 the Grant Writers have submitted the following grants:

In addition to the community grant applications, the Grant Writers have also been working on various grant writing related administrative tasks, and working with PRRD staff on a number of internal grant requests, including the Chetwynd Library and Kelly Lake Community Center. NDIT Grant Writer Support Program

The Northern Development Initiative Trust (NDIT) Grant Writing Support program provides annual funding for a grant writing position to eligible local governments and First Nations located in the NDIT service region. NDIT will provide up to \$8,000 to a maximum 76% of eligible grant writer wages each calendar year. Eligible Grant Writer positions must spend a minimum of 400 hours on grant writing services, and apply for a minimum of \$200,000 worth of grant funding.
