Subject: North Peace Leisure Facility Replacement Steering Committee Terms of Reference

RECOMMENDATION: [Corporate Unweighted]

That the Regional Board adopt the North Peace Leisure Facility Replacement Steering Committee Terms of Reference that sets out the roles and responsibilities assigned to the Steering Committee Members by the Regional Board; further, that the North Peace Leisure Facility replacement feasibility project resume in early 2022.

BACKGROUND/RATIONALE:

On September 9, 2021, the Regional Board passed the following recommendation:

MOVED, SECONDED and CARRIED

That the Regional Board defer the adoption of the North Peace Leisure Facility Replacement Steering Committee Terms of Reference until the City of Fort St. John, the District of Taylor and the Peace River Regional District have had the opportunity to discuss future funding models for the facility.

The Regional District's Chief Administrative Officer (CAO) has met briefly with CAO's from the City of Fort St. John and the District of Taylor at the Board's direction to discuss future funding models for the facility. All parties were in agreeance that funding models should be explored in parallel of completing the feasibility study that had currently been paused while the particulars of the terms of reference for the project were sorted out. It is recommended that the Terms of Reference be adopted and the project resume early 2022.

ALTERNATIVE OPTIONS:

1. That the Regional Board provide further direction.
