Subject: Financial Plan Amendment Bylaw 2465, 2021 – Five Year Financial Plan

RECOMMENDATION: [Corporate Weighted]

That the Regional Board give "PRRD Five Year Financial Plan (2021-2025) Amendment Bylaw No. 2465, 2021" first, second, and third reading.

BACKGROUND/RATIONALE:

Due to the COVID Restart monies received and allocated internally from the Rural Budgets Administration Committee and four other budget amendments throughout the year, the 2021-2025 Five Year Financial Plan must be amended as these amounts are material. The COVID funds have been added into the budget, along with some transfers from operating reserves to cover unanticipated costs. These changes are captured in the Five Year Financial Plan Bylaw amendment (Bylaw 2465).

Schedule "A" has been amended in 2021 to:

Revenue: (total increase \$1,236,143)

- Increase Reserve revenue by \$707,840
- Increase Operating Reserve revenue by \$528,303

Expense: (total increase \$1,236,143)

- Increase Capital expense by \$197,045
- Increase Other Purpose expense by \$1,039,098

The same changes are applicable to Schedule "B" for the 2021 year, which shows greater detail for each function. Functions affected are as follows:
