- Director Goodings asked what the intent is, now that the assessment to the Cache Creek Community Hall has been done, to get feedback from the community members as to what they would like see done with the Community Hall. Trish Morgan noted that the PRRD will be sitting down with each of the Community Halls and their Area Directors to go over their condition assessments and to come up with a plan to address the needs of the halls.
- Director Sperling asked if the engineering study on the Charlie Lake Fire Hall
 was a standard recommendation when the building was built at two separate
 times. Meaghen responded that is was visual and reported by the onsite staff
 that there was an issue. Trish Morgan also stated that there are issues with
 the flooring and that they would have to look into the files on the building
 structure.

 year term was because of the age of the buildings. Meaghen said that, that is
 the standard in the industry, to assess your buildings every 5 years.

Chair Sperling — BC Rural Centre

Director Sperling and Director Hiebert participated in an interview with the BC Rural Centre regarding the Keeping it Rural Conference. Chair Sperling – BC Rural Centre (Continued)

Director Sperling provided the Electoral Area Directors Committee with an update on a meeting with Minister Rankin, Ministry of Indigenous Relations and Reconciliation, and Minister Ralston, Ministry of Energy, Mines and Low Carbon Innovation, held on November 18, 2021, in Fort St. John. Director Sperling was invited on short notice; however, he asked for all of the PRRD Electoral Area Directors to participate in the conversation and noted the importance of having complete Regional representation in the discussions regarding regional matters.

MOVED Director Sperling, SECONDED Director Hiebert,

That the Regional Board authorize a letter to be sent to Premier Horgan, Minister Rankin, Ministry of Indigenous Relations and Reconciliation, and Minster Ralston, Ministry of Energy, Mines and Low Carbon Innovation, requesting that when Ministers visit the Peace Region, all of the Regional Board Members be invited to participate in discussing regional issues.

Director Goodings asked the Electoral Area Directors Committee if the Committee was interested in re-creating the Agriculture Advisory Committee. In response, Director Sperling suggested that the Committee wait until that the Synergy Group, has a chance to meet in the new year.

Director Goodings expressed interest in Area B joining the Synergy Group. In response to Director Gooding's question, the Electoral Area Manager noted that there is a contract with Rick Anderson Consulting to facilitate the Synergy group, and if Area B wanted to be included, the contract would need to be amended and brought to the Board for consideration.

Director Goodings raised concerns for rural residents who experience power outages for long periods and asked the Electoral Area Directors Committee to discuss options for those residents to purchase a residential generator.

That the Electoral Area Directors Committee recommend that the Regional Board authorize a report to be brought back to a future Electoral Area Directors Committee meeting with options on how the PRRD can support rural residents who experience extended power outages to purchase a residential generator.

Director Hiebert – Water Conservation Plan

Director Hiebert verbally updated the Electoral Area Directors Committee with brief information regarding meetings with the District of Taylor regarding their water exploration. Director Hiebert posed a question to staff regarding a Regional Water Conservation Program. In response to Director Hiebert' question, the Chief Administrative Officer stated that the PRRD does not have a Water Conservation program. Director Hiebert noted that the Regional District would not be eligible to apply for applicable grants without a program in place.

That the Electoral Area Directors Committee recommended that the Regional Board authorize a report to be brought back to a future Electoral Area Directors Committee meeting with grant options to develop a Regional Water Conservation Program.
