In response to Director Fraser who asked for confirmation of the current status of the Adeline Kelly Building construction to an F2 standard as per the submitted plans, the PRRD Building Inspector stated that the construction of the building was not completed to the standards specified in the original engineering drawings submitted with the Building Permit showing it was intended to be constructed and used as an F2 (storage) building and not for public occupancy, and does not meet the F2 standards at this time.

In response to the Directors question on the cost for a feasibility study/business case on the Adeline Kelly Building at the North Peace Fall Fairgrounds, the General Manager of Community Services indicated that similar studies were being conducted, and the cost could vary depending on the scope of work required starting at approximately \$15,000 for a simple business case and up to \$50,000 for a complete needs assessment and feasibility study. A further discussion arose on financial implications and which function the money would come from. The Chief Administrative Officer noted that there were options, one being the Regional Parks Function 200, stating that any financial changes would require an amendment to the budget.
