LXL Consulting Ltd ("LXL"), is proposing to conduct geophysical activities for the above referenced geophysical program, as shown on the attached map. The purpose of this letter is to provide you with information regarding the proposed project, which is on or within 400m of your property/tenure. Permits issued over private land to conduct geophysical activities are subject to an agreement with the landowner.

The proposed 3D seismic lines will be constructed utilizing mulchers to a maximum width of 3.0m. Low Impact Seismic (LIS) and Avoidance (meandering) cutting techniques will be utilized on all new mechanically constructed lines. Existing access may be cleared with mulchers to a width of 3.5m. Hand cuts will be a maximum of 1.75mmulchers. There are no odours associated with geophysical operations. Dust will be minimal, as most of this project will be done under frozen ground conditions, during the winter. Vehicle traffic throughout this project will be mainly pick-up trucks. The use of larger trucks or truck and trailers will be utilized to haul mulchers, drills and recording equipment in & out of the area. There will also be ATV/UTV's used. Noise should be minimal; operations will take place between the working hours of 6:00am to 9:00pm at which time you may hear; mulchers, chain saws, drilling equipment or vibroseis units as well as helicopters. During the recording phase, depending on your proximity to the field acquisition you may hear the detonation of charges.

Section 144 of the Petroleum and Natural Gas Act states if the landowner has not consented to geophysical activity through written permission, the permit holder is not authorized on that land to conduct activities (despite holding a permit approval from BCER), nor can they seek right of entry from the SRB (Surface Rights Board). No activity will take place without your written consent.

It is the intention of LXL to make application to the BCER for approval of the above noted Geophysical program 45 days after the date of this letter. Field operations are proposed between Sep 1st, 2023, and May 15th, 2024.

There is a 44-day period you may respond to LXL, in writing, that you:

- Do not object to the application, or
- Set out reasons why the proposed activities should be modified or should not be carried out

Please be aware that you may also make a written submission, under section 22(5), directly to the BCER regarding an application at any time prior to the application decision.
