A bylaw to amend "Peace River Regional District Zoning Bylaw No. 1343, 2001."

Schedule A Map 1 of "Peace River Regional District Zoning Bylaw No. 1343, 2001" is hereby amended by rezoning a 4.1 ha (10.13 acre) portion of the Southwest ¼ Section 22, Township 85, Range 20, W6M, PRD, <u>from A-2</u> "Large Agricultural Holdings Zone" <u>to C-2</u> "General Commercial"; with the remainder 60.6 ha (149.7 acres) portion being rezoned <u>from A-2</u> "Large Agricultural Holdings Zone" <u>to A-1</u> "Small Agricultural Holdings Zone", as shown on Schedule 'A' which is attached to and forms part of this bylaw.
