## PEACE RIVER REGIONAL DISTRICT Bylaw No. 2521, 2024

A bylaw to amend 'South Peace Sub-Regional Recreation and Cultural Services Conversion Bylaw No. 2453, 2021".

WHEREAS, the Peace River Regional District was granted the function of 'Sub-Regional Recreation and Cultural Services' by Supplementary Letters Patent dated May 15, 1981, as amended; and

WHEREAS, the Peace River Regional District wishes to amend the service by expanding the scope to include the ability to provide grants to youth sports organizations and 4-H Clubs to fund travel and activities, and the ability to provide high school scholarships and bursaries in the rural participating areas; and

WHEREAS the *Local Government Act* allows for the amendment of a service establishment bylaw so long as the requirements of the legislation are met, and the Peace River Regional District has met those requirements, including obtaining written consent from the participating areas and approval from the Inspector of Municipalities;

NOW THEREFORE, the Board of the Peace River Regional District in open meeting assembled, enacts as follows:

## **ADMINISTRATIVE PROVISIONS**

- 1. This bylaw may be cited as "South Peace Sub Regional Recreation and Cultural Services Amendment Bylaw No. 2521, 2024".
- 2. If any portion of this bylaw is declared invalid by a court, the invalid portion shall be severed, and the remainder of the bylaw is deemed valid.
- 3. The headings used in this bylaw are for convenience only and do not form part of this bylaw and are not to be used in the interpretation of this bylaw.

## AMENDMENTS

South Peace Sub-Regional Recreation and Culture Services Conversion Bylaw No. 2453, 2021 is hereby amended as follows:

- 4. Delete all references to **PARTS** in the convenience headings, including the number assigned to each PART.
- 5. Under the **SERVICE** heading Section 6 b) is amended by inserting the words 'and facilities including maintenance, and capital improvements to existing facilities' immediately prior to the phrase 'in the service area.

6. Under the **SERVICE** heading, insert new Section 6c) as follows:

"c. the provision of grants to youth sports organizations for sports travel outside the region associated with provincial, national or international sporting competitions".

- Under the SERVICE heading, insert new Section 6d) as follows:
  "d. the provision of grants to 4-H Clubs for youth travel associated with 4-H Club activities."
- Under the SERVICE heading, insert new Section 6e) as follows:
  "e. the provision of scholarships and bursaries to high school students in the service area to support pursuit of post-secondary education."
