Dear Chair Brad Sperling:

Thank you for your correspondence received on January 30th, 2024, addressed to The Honourable David Eby, Premier, and myself, concerning the *Emergency and Disaster Management Act* (EDMA). I would also like to thank you for meeting with me on March 26th to further discuss EDMA.

In response to the questions and feedback that I have received from a range of local governments, I have sent a letter dated March 12th, 2024, to all mayors and regional district chairs across the Province that provides clarity on the most common concerns raised. As I noted in my letter, I appreciate the suggestion of a regional districts working group as a potential way to ensure regional district concerns are fully understood and EMCR will take this into consideration as we continue regulation development.

We are also working to produce and public helpful guidance on the EDMA (<u>gov.bc.ca/gov/content/safety/emergency-management/local-emergency-programs/local-gov-operations</u>), and technical questions can be referred to your local regional office or to <u>modernizeEM@gov.bc.ca</u>.

I am sincerely grateful to all of the local governments that provided a submission in response to engagement that took place from October 2023 through January 2024 on the modernization of regulations for local authorities and for disaster financial assistance. All feedback we have received from local governments will be considered as part of our work to develop regulations under the EDMA. There is also a five-year review of the Act that is mandated under the legislation.


