**Describe the project for which your organization is requesting a grant and the reason for your request.**

Thank you to all who are involved in the Community Works Gas Tax Grant Committee in reviewing this application for a sorely needed playground at Baldonnel Elementary School. We, the Baldonnel Elementary School Parent Advisory Council (PAC), are requesting a large grant to create recreation infrastructure for use and enjoyment by the immediate and surrounding Baldonnel and Two-Rivers Community. We are a not-for-profit organization who are requesting the funding for a new playground that will be located at Baldonnel Elementary School but open to public use and benefit, even during school hours! Our organization is requesting a \$315,317.10 grant to cover all costs of a new playground, including groundwork, required poured rubber surface, infrastructure supply and professional installation (following all requirements set out by School District 60). Attached is a letter of support from SD60, community members, Baldonnel School and local user groups. Also included in this proposal are the budgetary requirements to build a new intermediate playground that will greatly benefit all students in Baldonnel School, the entire Baldonnel community and surrounding Fort St John area for many generations to come. As a PAC, we have successfully completed community minded projects in the past and are dedicated to meeting this current community need. The monetary grant request is significant but our resolve to see positive change is far greater.

There has been an urgent need for the last five years at Baldonnel School, and in the community, for an intermediate playground. The previous playground was removed by our School District due to safety concerns and with no budget for a replacement playground, the area has remained a very bare and unusable space for students and community members alike. We, the members of the Baldonnel Parent Advisory Council, are committed to changing the landscape of play for Baldonnel students and community youth. This playground is imperative for the safety of students, the physical development of all community children, development of imagination, as well as fostering co-operative community enrichment. Free play is a contributing factor in the successful development of imagination, problem solving and teamwork. All these traits are imperative to the successful raising of today's youth. Baldonnel Elementary School is the hub of the Baldonnel, Two-Rivers/Sunrise, Peace Country Trailer Park, Forest Lawn Trailer Park, and Airport Subdivision communities. It is the site for community gatherings, organized sports, rural-activities, family gatherings, and many other community-wide events. The lack of an intermediate playground extends far beyond just lunch-hour for students at the school. Our organization is comprised of parents, knowing the needs of not just the students, but other children, other schools and groups is paramount to our success as individuals. This request is first and foremost for the current and future generations of Baldonnel, local communities, Fort St. John, and surrounding area. Many Fort St John user groups utilize our gymnasium, ice rink and nearby open fields for various and re-occurring events. This recreation infrastructure will serve to be a well utilized, tangible benefit for the entire local community and surrounding area.

The cost of living has substantially increased over the last five years. Unfortunately, playground equipment, site prep, required rubber matting, and required professional set-up has followed the same increase. This specific playground design has not been installed in the Baldonnel/Taylor/Fort St John/Charlie Lake area before. It's unique design accommodates a high number of approximately 50 children playing co-operatively all at one time. Sight-lines around and through the playground add to the safety of its design. Open sight lines give teachers, monitors, parents, and care givers alike the ability to watch their children while still allowing for independent play. This social and mental development creates self-confidence and self-awareness which is paramount for the development of today's youth.

This playground design is geared towards older children (8 years and up) but also offers thoughtful, on the ground pieces for younger siblings and younger children. Multi-generation families make up the fabric of the Baldonnel and surrounding communities and our goal is to create a safe, clean, and imaginative play space for all age groups. Baldonnel/Two-Rivers has a rich history that follows generations of families growing up in the area, returning to raise their own children in the same place they once loved and adored. Boasting a diverse school community that includes rural residents, home-school students, private school students as well as a close connection to city residents, Baldonnel truly is a special community. This playground will be a significant benefit for generations to come in the entire community as a whole; not just one Elementary School. There are no other places of free public engagement, other than the Baldonnel Elementary School area (Women's Institute land is adjacent to the school and the open field/outdoor ice rink is included in the Baldonnel School area). This new, thoughtful recreation infrastructure will tie in perfectly into the existing infrastructure network and provide a tangible benefit that aligns with strong communities. The hallmark of a strong community are forward leading practices that are accessible and relevant to the very youngest user group, to the very oldest. As a PAC we work diligently to help foster an environment for children to grow, learn and thrive. This playground will be a source of learning, imagination, co-operative play, physical challenge, and social-emotional development. All these traits are paramount to the successful productivity inside a classroom, sports-center, family function or future career. Our proposed project is not a private venture, as mentioned it serves a community wide need that will build a strong dynamic between young and old in the Baldonnel, Two-Rivers and surrounding Fort St. John area.

In entering a partnership with the PRRD we would like to acknowledge the PRRD in many different capacities for the support in our endeavor to create a community play space. PRRD logos on flyer's, materials, annual reports, and presentations would commence immediately (with PRRD approval). Recognition of this partnership would be done through radio announcements, articles in local news, social media sites and verbal acknowledgment at school events. Personalized "thank-you" from students and community youth would be publicly shared. A community wide FREE BBQ (provided by the Baldonnel PAC) and ribbon cutting ceremony would just be the start of a very celebratory and noisy campaign to spread the wonderful news of community enhancement. We appreciate the ability to make this request for funding of a recreational infrastructure project that will reach beyond our small PAC and into the larger community. As a PAC we are very grateful to be given the opportunity to apply for the Community Works Gas Tax Grant Fund and work in partnership with the Peace River Regional District to better our community.

Thank you for taking the time to read over our proposal and review the details of the Baldonnel Elementary School Intermediate Playground Budget. Included in this request is the project budget, including all sources of funding. Current financial statements showing revenue, expenses, and savings. The complete specs and price breakdown of the requested community infrastructure project. Letters of support from Baldonnel School, School District 60 and more importantly the students of Baldonnel Elementary and Baldonnel/Two-River's community members. "There is nothing permanent except change," (Heraclitus) and we as a collective are excited to pursue this change for our youth of today and tomorrow.

# Replacement of Baldonnel Elementary Intermediate Playground Equipment

In 2018 the Intermediate Playground Equipment at the Baldonnel Elementary School was removed by the School District 60 due to safety concerns and it had reached its end of life. School District 60 does not have a budget to replace the equipment or provide play structures for the Intermediate Students, despite it being provided by the District initially as part of the school set up. Children are currently utilizing minimal equipment or are sharing the Primary students play area, which was also provided by a previous PAC committee over a decade ago. Thus, the Baldonnel Elementary School Parent Advisory Council has taken the initiative to fund-raise and seek sponsorship for the purchase and installation of new equipment.

The minimal infrastructure in place can contribute to an imbalance to the development and behavior of the children in the community. Through play, children experience emotional, social, and physical growth. Increased self-esteem, improved collaboration skills, enhanced critical thinking skills, and a strengthened immune system are just some of the high-level benefits children gain by being able to play.

Why is playing important? Play is so essential for child development around the world that the United Nations High Commission for Human Rights recognizes it as a right of every child. Play is critical for kids to develop the emotional, social, and creative thinking skills they'll need when they're adults. Play allows them to engage with their surrounding environment and with others in their community in a fun context. It enables them to explore ideas and different ways to behave, testing their boundaries and growing in the process.

While the importance of playgrounds and free play in child development is clear for all kids — including those above the age of 12 — it's critical during the early school years. Play is how kids learn to socialize. It improves their thinking skills and problem-solving abilities and helps them develop many of the skills they'll need in adult life.

We are seeking sponsorship, or donations to purchase and install one new piece of equipment. The total estimated value of this project is \$315,317.10. This is the total amount needed to purchase replacement playground equipment, and pay for ground preparation, and installation of both the equipment and the rubber surfacing as required by the safety codes and specifications outlined by School District No. 60.

## **History and Mandate of the Baldonnel Elementary PAC**

The Baldonnel Elementary School Parent Advisory Council (PAC) has been active in Baldonnel since prior to 2002. We are a registered, not-for-profit society and are affiliated with BC Confederation of Parent Advisory Councils, which is the official governing body for the organizations.

The PAC provides a range of services and resources. It works towards providing opportunities to educate and inform parents about the school; involving parents in volunteer activities; and openly discussing parents' concerns and aspirations for their schools.

More than five years later, the students and community of Baldonnel, Two-Rivers, Peace Country Trailer Park, Forest Lawn Trailer Park, and Airport Subdivision still do not have access to an intermediate playground. I can attest to many user groups – such as Blizzard Bike Club, Community Baseball, Community Groups, Daycare groups and families utilizing Baldonnel School Grounds. A new playground would be a significant long-term benefit for all of Baldonnel and surrounding area, building cleaner and brighter futures for our children.

I have watched the Baldonnel Parent Advisory Council work tirelessly to build a sense of unity not only within Baldonnel School but the entire community.
