Grid bearings are derived from obervations between Geodetic control monuments GCM14H2729 and TH 'A' and are referred to the Central Meridian of the UTM Zone 10 (123rd Meridian of West Longitude). Datum: NAD83(CSRS) 4.0.0.BC.1 UTM Zone 10.

Estimated Network accuracy is 0.1 metres.

To convert plan bearings to local astronomic bearings referred to the meridian through PL TH'A', add 1° 45' 02".

The UTM coordinates and estimated absolute accuracy achieved are derived from NRCAN CSRS-PPP (Precise Point Positioning) by GNSS Observations.

This plan shows horizontal ground level distances unless otherwise specified. To compute grid distances multiply ground level distances by average combined scale factor 0.99970231

The average combined factor has been determined based on an ellipsoidal elevation of 677.2 metres.

All dimensions are in metres and decimals thereof.


