9.1 Director Sperling - Request for Discussion Re: Proposed Windfarms

That the Electoral Area Directors Committee approve a New Business Item being a discussion on proposed windfarms.

CARRIED

Directors discussed the proposed wind farms that were approved as part of BC Hydro's Call to Power. They were concerned that the Minister of Energy and Climate Solutions ignored community concerns over wind farms. Directors mentioned that the province had not conducted an environmental assessment on these wind projects and was ignoring community impact studies. They noted that during the recent provincial election the Premier had recognized the need to listen more closely to rural communities including those in the North, however based on their responses (re: windfarms, emissions caps and the oil and gas industry) it seemed the province was ignoring rural communities. They emphasized that the Regional Board needed to have a discussion on these issues and explore how to move forwards. Additionally, Directors noted that recent correspondence pertaining to these issues received from ministers, business groups and independent contractors should be reviewed at that meeting.
