Below is a summary of the change to the budget of Function 265 – Buick Creek Arena since the budget was recommended by the Rural Budgets Administration Committee on January 24, 2025, for approval by the Board:

 Funding in the amount of \$95,000 was allocated from the capital reserve in 2024 for the operating Society to complete a number of capital improvements at the Facility. The Society completed a project valued at \$21,384 and submitted the invoice after the budget was presented. This resulted in a \$21,384 reduction to the budget.
