Subject: Function 200 - Regional Parks Draft 2025 Budget

The following recommendation has been amended since approval at the December 12, 2024 Regional Parks Committee meeting as explained in this report.

### **RECOMMENDATION:** [Corporate Weighted]

That the Regional Board approve the draft 2025 budget totalling \$882,996 for Function 200 – Regional Parks, with a total requisition of \$467,972 and an estimated tax rate of \$0.0137.

## **BACKGROUND/RATIONALE:**

On December 12, 2024, the Regional Parks Committee passed the following resolution:

#### MOVED, SECONDED and CARRIED,

That the Regional Parks Committee authorize an amendment to the draft 2025 budget totaling \$852,374 for Function 200 Regional Parks, with a total requisition of \$536,625 and an estimated tax rate of \$0.0169 as follows:

- 1. Change the funding source of the Blackfoot traffic flow study (\$30,000) to Growing Communities (and move to capital).
- 2. Reduce the funding to the operational reserve from \$60,278 to \$21,625 resulting in a budget totalling \$813,721 with a total requisition of \$467,972 and an estimated tax rate of \$0.0147; further, that the resulting budget as amended be recommended to the Regional Board.

Below is a summary of changes made to the budget of Function 200 – Regional Parks since the budget recommendation was approved by the Regional Parks Committee on December 12, 2024:

- Total budget increased by \$69,275 from \$813,721 to \$882,996.
- Transfer from operating maintenance reserve increased by \$64,739, from \$171,499 to \$236,238 due to an increase in surplus from 2024.
- Transfer to capital reserve increased by \$64,739 from \$65,000 to \$129,739.
- An increase in 2024 capital surplus of \$4,536 was brought into the capital budget as surplus and then transferred to the capital reserve.
- The tax rate decreased by \$0.0008 from \$0.0145 to \$0.0137 as the tax rate for the December 12, 2024 meeting used the 2024 Revised Roll to calculate as the 2025 Completed Roll was not available until January 2025.
