

PEACE RIVER REGIONAL DISTRICT

BY-LAW NO. 993, 1995

The Board of the Peace River Regional District in open meeting assembled, ENACTS AS FOLLOWS:

1. The by-laws listed in Column 1 of Schedule "A" of this by-law may be enforced by means of a ticket in the form prescribed by the regulations adopted pursuant to Section 934.3(c) of the Municipal Act.
2. The persons who act in the job positions or titles listed in Column 2 of Schedule "A" to this by-law are designed by-law enforcement officers for the purpose of enforcing the by-laws listed in Column 1 of Schedule "A" opposite the respective job position.
3. The words or expressions set forth in Column 1 of Schedule "B" of this by-law designate the offence committed under the by-law section number appearing opposite the respective words or expressions in Column 2 of Schedule "B".
4. The amounts appearing in Column 3 of Schedule "B" of this by-law are the fines for contravention of the by-law offence set out in Column 1 of Schedule "B" of this by-law.
5. This by-law may be cited as "Ticket Information By-law No. 993, 1995".

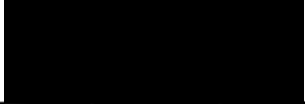
