7.1 Letter from Ministry of Water, Land and Resource Stewardship Re: Aquatic Harvester Approval for Charlie Lake

MOVED Director Sperling SECONDED Director Hiebert

That the Electoral Area Directors Committee receive the 'Letter from Ministry of Water, Land and Resource Stewardship Re: Aquatic Harvester Approval for Charlie Lake' which outlines the *Water Sustainability Act* approvals and conditions for removing aquatic vegetation from Charlie Lake for discussion.

CARRIED

The Committee raised concerns about the cost of cleaning up Charlie Lake. They noted that the Regional District lacked a service function that costs could be allocated to therefore any work done would be paid for using Fair Share funds. Noting that two boat launches were owned by the Province while another was owned by the City of Fort St. John, the question arose whether the PRRD had authority to do aquatic harvesting work at Charlie Lake.

Staff confirmed that while funding had not yet been allocated and no current planning was yet in place to undertake any aquatic harvesting work, the PRRD did have the necessary authority to proceed pending the Board's direction. The possibility of obtaining an extension to the permit timeframe (to 2026-2027) was also discussed. Directors discussed the need for further investigation regarding included bylaw formation, funding from the province, and forming a regional benefiting area. They discussed their shared

desire to hold community meetings to revisit the potential work involved with local groups and residents, and opted to seek an extension from the province to allow adequate time to explore things further.
