Subject: Environmental processes for Taylor Wind

Hi Leonard

Thanks for your letter from a couple weeks ago regarding Taylor Wind environmental process. EDF Renewables and Saulteau First Nations are collaborating to develop the Taylor Wind Project and we look forward to working with PRRD as this project moves forward.

Taylor Wind requires authorizations from the Government of BC for use of Crown land, for resource uses, and to permit non-farm use of the Agricultural Land Reserve. Changes to the regulatory process for these authorizations are currently in progress as the new regulator, the BC Energy Regulator, assumes responsibility and develops the environmental process that we will follow. Until the new legislation to enact this change is passed by the BC Government, and the Regulations are developed, we are not able to answer your questions on the environmental processes.

Taylor Wind will also be regulated by the PRRD, as portions of the project are located on fee simple property zoned as A-2 Large Agricultural Holdings. It is anticipated that re-zoning will be required. We are committed to continue working with the PRRD to meet your requirements, and hope that we can integrate as many of your and the future BC Government requirements to be thorough and efficient.

To that end, could you let us know when you are available to meet to discuss the best way to meet your requirements? Looking forward to working with you on this.
