## **MACKENZIE TSA TSR – DATA PACKAGE REVIEW AND COMMENT**

Dear Shawn Dahlen

The Ministry of Forests, Lands, Natural Resource Operations, and Rural Development (FLNRORD) is conducting a timber supply review (TSR) that will assist the chief forester in determining a new Allowable Annual Cut (AAC) for the Mackenzie Timber Supply Area (TSA). First Nations, forest licensees, and the public are invited to review and provide comments on the Data Package between November 19 and January 18, 2021.

The TSA land base area affected by this AAC decision is approximately 6.4 million hectares and it is administered by the Mackenzie Natural Resource District office in Mackenzie.

The Data Package provides a general description of the TSA, a brief history of the TSA, and a draft of the data and management assumptions that will be applied to the upcoming timber supply analysis. Comments received during the Data Package review period provide the chief forester with valuable information required to determine a new AAC - the maximum volume of timber to be harvested from the TSA - for the next 10 years.
