

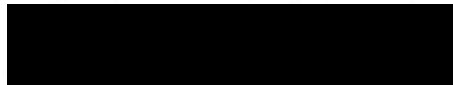


Conditional Ministerial Order Conferring Reserve Status

Pursuant to subsection 4(1) of the *Addition of Lands to Reserves and Reserve Creation Act*, SC 2018, c 27, s 675.

I, Gary Anandasangaree, Minister of Crown-Indigenous Relations and Northern Affairs, at the request of the council of Blueberry River First Nations, pursuant to subsection 4(1) of the *Addition of Lands to Reserves and Reserve Creation Act*, SC 2018, c 27, s 675, and in accordance with the Blueberry River First Nations and Doig River First Nation Treaty Land Entitlement Settlement Agreement between Blueberry River First Nations, Doig River First Nation, the Province of British Columbia and Canada and the Blueberry River First Nations Lands Agreement between Blueberry River First Nations, the Province of British Columbia and Canada, effective February 16, 2023, hereby set apart for the use and benefit of Blueberry River First Nations as Charlie Lake, in the Province of British Columbia, the lands described in the attached Schedule, consisting of about 261 hectares (645 acres), effective on the day on which His Majesty the King in right of Canada accepts the transfer of the administration and control of the lands from His Majesty the King in right of the Province of British Columbia pursuant to the *Federal Real Property and Federal Immovables Act*, SC 1991, c 50, and *Federal Real Property and Federal Immovables Regulations*, SOR/92-502.

**Re: Proposed Reserve Creation – Blueberry River First Nations
Treaty 8 Land Entitlement Shortfall Lands – Charlie Lake Land Selection**

Blueberry River First Nations (“Blueberry River”), the Province of BC and Canada finalized the settlement of treaty land entitlement on February 3, 2023. The settlement resolves the Treaty 8 land entitlement claims of Blueberry River.

Under the terms of the settlement, it is contemplated that Blueberry River may apply to add provincial Crown land as reserve in accordance with, and subject to, fulfilment of the requirements of Canada’s Additions to Reserves/Reserve Creation policy. These requirements include notification to local government.

I am writing to inform you that Blueberry River has, by way of a Band Council Resolution, submitted a request to Indigenous Services Canada (ISC) for Reserve Creation. Blueberry River has requested that certain lands located in the Peace River Regional District be set apart as a reserve to be known as Charlie Lake (the “Proposed Reserve Creation”) under the settlement. The lands for the Proposed Reserve Creation are surveyed provincial Crown lands currently described as:



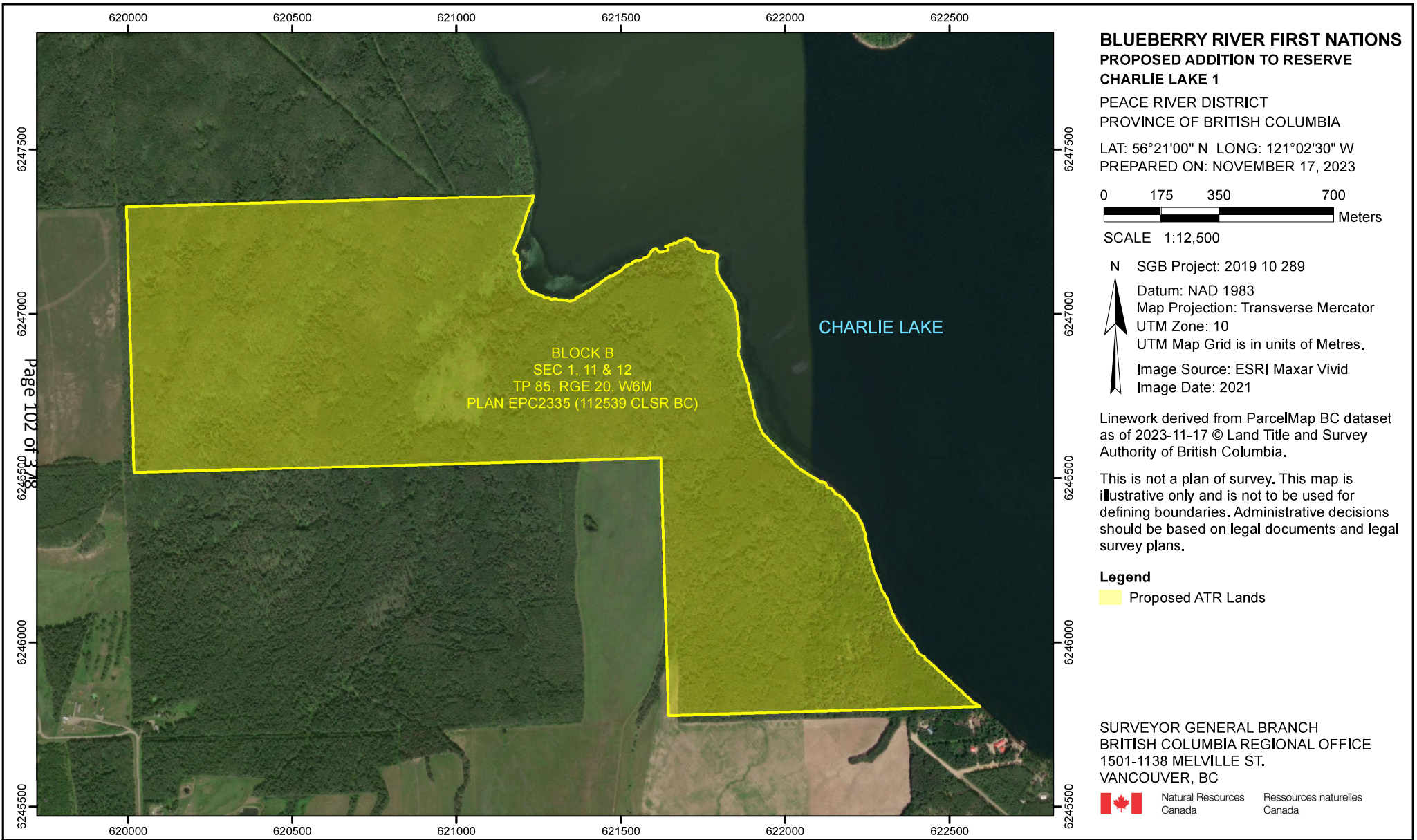
