# ITEM 1.0 - Territorial Acknowledgement Introduction and Welcome

• We respectfully acknowledge that the communities of Northeastern BC are situated on the traditional territories of the Dane-zaa, Dene, Cree, Dunne Tsaa, Tsáá? Ché Ne Dane, Tse'khene, Dene Tha', Kaska peoples, Dunne-za, and the Métis Nation BC Region 7. The Northeastern BC Collaborative Accessibility Committee recognizes the many Indigenous communities with ongoing connections to the land base on which we are situated and the many more whose communities have meeting grounds, gathering places and travelling routes across the region. We recognize and value the significant contributions of Indigenous Peoples who have lived and worked on this land since time immemorial.

#### ITEM 2.0 – Guest Presentation

- City of Fort St. John will be presenting looking to amend the City's process to better define criteria for approval on street accessible stalls for downtown businesses and to add certainty to if/when an accessible stall gets removed.
- Guests from the City of Fort St. John: Robert McGuire and Sam Loran.
  - of respondent had mobility issues. A quarter of the respondents were only willing to travel 200 feet from a parking stall to the business. 17% where willing to travel 300 feet and the remaining would travel 350 feet or more from the parking stall to the business. Have received numerous requests for more accessible parking stalls. 101st Ave has a cluster of health businesses that should have accessible parking stalls. Have met one on one with Lori Slater and SPARC BC about accessibility issues in the past. There are currently 304 placard holders in Fort St. John. Currently accessible stalls are only put in when a business requests them.
  - We are looking for on street parking only for this new process. Wanting to have a best practice for this process in place.
- There are three questions they would like some input from this committee on:

- 1) 101st Avenue is a cluster of health offices and high traffic businesses. Are ramps necessary for each accessible stall? Does each accessible stall need their own letdown?
- 2) Placement of let downs can existing let downs be used especially where areas have a slimmer sidewalk there may not be enough room to have a letdown at each accessible stall. The offices along 101<sup>st</sup> Avenue have been identified, are there any other business that should have a letdown.
- 3) What types of business are really needed to have these accessible stalls.
- Isha askes Kristi and Diana to speak to these questions.
  - Krist thank you for bringing this to our committee. This is the purpose of this committee and we are all working together. As a wheelchair user the only trouble is where you put the ramps, make sure no one can park near it or in front of it. People with disabilities need to be able to go everywhere. The goal is to have these everywhere.
  - Diana I have mobility issues and pain issues and do not visit Fort St. John very often. And when I do its only for a medical appointment. Let downs are very difficult as I can stumble or trip when using a cane at the letdown, so I avoid them. Narrow sidewalks with a letdown also are difficult.
- The committee will discuss the questions and will respond back to the City of Fort St. John.

- o Choose a focus area or topic each year to guide action plans.

## Long term goals

- Formalizing their role in municipalities by being part of a referral process on major projects or projects with an accessibility component or that may benefit from an accessibility lens.
- Have collaborative relationships and/ or projects with Accessibility Committees from other prescribed organizations.
- Host or attend public events to raise awareness of accessibility issues.

- Letter to municipalities.
- Presentation to municipalities.
- Letters to other committees, organizations and the public.
- Media campaign materials to raise awareness of the feedback mechanisms.
- o Business and events accessibility information sheets.
- Materials to promote National Accessibility Week 2026 and July Disability Pride and Awareness Month.

#### Discussion:

• Support our member municipality. A way we can reiterate our value and the work that we do. By forming a working group with a few of our committee members. There are some funds in the budget to support this task. Isha and/or Kenna can support with the letter drafting or refining and the broader community providing some media material to highlight the feedback mechanism all across the region. One single email that comes to this committee from all member communities is amazing. Have not had a ton of responses to date as this will require some promotion.

- Talked about creating a list of business or anyone applying for an event license so we can
  create awareness for these business how they can contribute to this. Once pager on why
  this is important and some key things they can do and some resources that can improve
  accessibility. Early in the new year we were to create materials to go with the accessibility
  week. Kristi and Lori have been keen to get out there and attend events.
- It was noted that July is disability pride month and this should be added to the list. Agreed, this should be added to the list.
- Kristi comments that she is able to come back to Fort Nelson permanently and excited to get back into her community. Fort Nelson has been working on a lot of accessible areas and she is very proud of her community.
  - o Isha has recruited Kristi to be on the working group to help write letters to the municipalities on accessible. Raising awareness with municipalities is the logical first place to start. Isha and Kristi will choose a time when they can meet to support this work and work together. Would be fantastic to have a municipal staff in this conversation as well to help support that the letter will be written the way the municipality wants to receive it. Steve can help with this process as they should be to the point. Steve, Isha and Kristi will work together on this. A lot depends on the mayor and council on how they want to receive it.
  - There will be three working groups. Red shirt day and disability pride month, raising awareness with municipalities (letters presentations), and raising awareness with the public.
- It was noted that Lori is still recovering and on leave. She will be off another month or so but wants to also be apart of these working groups.
- Isha will arrange some group training session for July and August and will record for those
  that cannot make it. This way we can stay on track with our goals. Inviting select delegates
  to attend upcoming meetings, she will also set up an executive meeting to ensure we are
  on track.
- Discussion on disabled washroom and handicap stalls.
