# BACKGROUND/RATIONALE:

The Peace River Regional District (PRRD) initiated this Regional Growth Strategy (RGS) in March 2022. The RGS is a long-range, high-level plan that will help the PRRD and member communities (City of Dawson Creek, City of Fort St. John, District of Taylor, District of Chetwynd, District of Hudson's Hope, District of Tumbler Ridge and Village of Pouce Coupe) better understand and prepare for the potential changes that can be expected over the next 20 years due to a growing population, new service demands and affordable housing challenges, among other issues.

All affected local governments have provided resolutions in support of the Regional Growth Strategy.

As part of this project an implementation and monitoring plan has been developed, and staff will provide yearly updates as to progress.

#### **Summary of Procedure**

Regional Growth Strategy Bylaw No. 2571, 2025 was read for a first and second time on March 20, 2025. The following activities have occurred since then:

April 1 & 9, 2025: Public notification posted on the PRRD website and Facebook page.

April 10, 2025: Public Hearing held in Dawson Creek.

April 10, 2025: Referrals sent to all municipalities, adjacent Regional Districts and the Ministry

of Housing and Municipal Affairs.
