

The current “ask”

1. Retain 100% Legal Axle Loading on previously strengthened roads
2. Upgrade grid roads to 100% legal axle loading
3. Continue to build pullouts
4. Gravelling, ditching and brushing

Community Meetings with Results

Prespatou (2019)

- Pullouts construction

Milligan/PJ (2019)

- Preservation of Pavement

Lower/North Cache (2020)

- Critical maintenance completed

Pullouts

- Address concern of narrow, steep shouldered paved roads
- Embraced by MoTI as a compromise. Estimated \$100,000 each.
 - 2019 – 1 completed on Prespatou road
 - 2020 – groundtruth multiple locations
 - 2020 – prioritized by the Rural Roads Task Force
 - 2020 – 4 completed (Prespatou, Beatton Park, Clayhurst roads)

Financial Impacts

- **Direct Impact**
 - Annual Budget maintenance 2018 – 2020 - \$20 million x 10-20% x 3 years
 - New local program Pullout Installation – (2019 – 2020) 5 x \$100,000
 - Milligan/PJ resurfacing - \$4 million
- **Indirect Impact**
 - 2020 Rose Prairie hot in place recycling (59 lane km.)
 - 2020 side road patching (46.9 lane km.) – (Milligan, Montney, Siphon, Cutoff, Clayhurst)
 - Gravel program input/response
