

BY-LAW NO. 520

A By-law to revise the boundaries of the  
Dawson Creek-Pouce Coupe Rural Fire Protection  
Specified Area within Electoral Area "D"  
of the Regional District of Peace River-Liard

WHEREAS the Regional Board of the Regional District of the Peace River-Liard has passed By-law No. 361 being the Dawson Creek-Pouce Coupe Rural Fire Protection Specified Area Establishment and Loan Authorization By-law No. 361, 1983, and By-law No. 416, being the revision to the boundaries of the Dawson Creek-Pouce Coupe Rural Fire Protection Specified Area By-law No. 416, 1984;

AND WHEREAS by petition, the Regional District has been requested to revise the boundaries of the specified area;

AND WHEREAS the Village of Pouce Coupe, the Regional District and the sole property owner affected are in favour of such extension;

NOW THEREFORE, the Regional Board of the Regional District of Peace River-Liard in open meeting assembled, enacts as follows:

- 1) The Regional Board is hereby empowered and authorized to revise the boundaries of the specified area known as the Dawson Creek-Pouce Coupe Rural Fire Protection Area within Electoral Area "D" by incorporating into the specified area the property described as a Fractional Northeast Quarter of Section 14, Township 77, Range 14, West of the Sixth Meridian;
- 2) This By-law may be cited as the "Revision to the Boundaries of the Dawson Creek-Pouce Coupe Rural Fire Protection Specified Area By-law No. 520, 1987".
