Firstly I would like to Thank You, for the opportunity to comment on the application for construction of the Blackbird Environmental 500 Man camp.
My name is Brad Cameron, I have been the GM of the Wonowon Lodge (Mile 101 across form Blueberry Esso) for 6 Years. I have recently taken the business over from my father, Dwayne Cameron.
We are private business, servicing LNG workers and oilfield completions. The camp has been in operation since 2010 and has been the answer to a lot of the accommodations requirements along the highway.
We currently provide 300 beds, typically in our busy season we run at roughly 65% to 75% and right now heading towards break up 10%-12% of capacity. Throughout this past winter 2020-2021 we have been running at 35%-40% capacity. I am sure our competitors to the East and West of us a few miles away, would confirm these numbers as well.
Not exactly sure why anyone would consider a 500 man camp at this point, as we have considered expanding on our cleared land we own. The covid/economy have deterred that consideration, all together at this point.
My father has lived in the local area for over 20 Years and I have lived in the Peace River District for over 6 years. As a PRD tax payer, I am opposed to this 500 bed camp. If this camp is allowed to be put into operation, it will have a negative impact, on all existing lodging facilities in and around Wonowon including the local suppliers we use from Fsj. It literally could cause many Wonowon businesses, to close their doors. The demand at this point is simply not there.
