## PURPOSE

The Dawson Creek and District Hospital (DCDH) Redevelopment Capital Project Advisory Committee ("the Advisory Committee") has representation from Saulteau First Nations, West Moberly First Nations, Kelly Lake Cree Nation, First Nations Health Authority, Peace River Regional Hospital District (PRRHD), Municipality of Dawson Creek, BC Patient Safety & Quality Council (BCPSQC)/Patient Voices Network and the South Peace Health Services Society. The Committee will provide advice and recommendations to Northern Health on:

- Local <sup>i</sup> considerations related to the Project.
- Patient experience and cultural considerations related to the design and health services contemplated within the project scope.
- Capital Project consultations and communications related to the Project.
- Working groups for topical issues for broader input as required, such as:
  - First Nations advice.
  - Culturally appropriate design input.
  - Other topics as deemed appropriate by the Advisory Committee.
- Local issues and concerns that may affect the Project.

- Reporting: A meeting summary will be produced after each meeting, highlighting key points discussed in the meeting
  - These meeting summaries will be distributed to members via email, and will also be made available online on the Northern Health website under 'About Us', Capital Projects.
- Meetings will be in person. Attendance via videoconference or teleconference is also acceptable, and will be arranged by Northern Health administrative staff.
- A representative of the Project Management Office will attend to provide project status reports.
