 - Description of their portfolio.
- Honourable Mike Farnworth, Minister of Public Safety and Solicitor General regarding:
 - o The Peace Regional RCMP Proposal.
 - Reinstatement of GIS unit.
- Honourable Bruce Ralston, Minister of Forests regarding:
 - Forestry permits.
 - Woodlot licences.
 - BC Timber sales.
- Honourable George Heyman, Minister of Environment and Climate Change Strategy regarding:
 - New Landfill.
- Honourable Adrian Dix, Minister of Health regarding:
 - Emergency Room diversions.
 - Support for Northern Health.
- Honourable Jennifer Whiteside, Minister of Mental Health and Addictions regarding:
 - Lack of mental health facilities.
 - Northwinds Facility scope being reduced due to lack of support and funding.
- **Premier Eby** regarding:
 - Holding the Ministry of Mental Health and Addictions accountable in regard to the Northwinds Facility scope.

OTHER CONSIDERATION(S):

Due to the volume of meeting requests and scheduling availability during the busy UBCM Convention, the Regional Board is asked to rank the priority order for Minister meetings at the event (most important to least important).

Should the Board decide to request more than the recommended three meetings, the priority ranking of the Minister meetings at UBCM will assist staff in coordinating arrangements with the various ministries as not all Minister Meeting Requests are successful.

In the past, each Minister meeting request has been limited to three topics. Each topic submitted must include a brief summation of what the Regional Board would like from the meeting, with a brief backgrounder (maximum 700 characters) about the topic which must be submitted with the meeting request to provide a complete picture of the topics to be discussed.
